## Admission Notice

Applications are invited for admissions to the various Trades/Courses conducted in the various ITIs of the State. The location of the ITIs and the Trades conducted therein are given in the Annexure to this Notice. The Application Forms for Admissions will be available in all the ITIs from 24 -06-2013 to 06-07-2013 and can be obtained against a cash payment of Rs. 40/- each. The Prospectus can be down loaded from the website of this Directorate on <a href="https://www.jkdte.org">www.jkdte.org</a>. The last date for submission of application forms will be 09 -07-2013. Detailed information can be had from the concerned Heads of ITIs. The entry qualification of the Trades is 8<sup>th</sup> pass to 12<sup>th</sup> pass depending upon the Trade, which can be ascertained from the respective Heads of ITIs as is also available in the Prospectus. The duration of the courses/Trades is 6 months to 2 years. The academic session will begin from 1<sup>st</sup> August, 2012. The following criteria is applied for making admissions in the ITIs.

- The candidate must be the permanent resident of Jammu and Kashmir State.
- The lower age of the candidate applying for admissions is 14 years. However, there is no upper age limit to apply for admissions in any of the Trades.
- The candidate must possess minimum educational qualification prescribed for the desired Trade/Course.
- Candidates, who have already undergone training in any of the Trades of ITIs, can apply for admissions in another Trades 2 years after completion of previous training course. However, for the ensuing academic session their admission can be considered in any of the Trades having poor response.

**Note:** It is clarified for the general information that the candidates seeking admissions in the NCVT Trades (affiliated to NCVT) will be awarded National Trade Certificates by the National Council for Vocational Training, GOI on their successful qualification of ensuing All India Trade Test. While as, the candidates seeking admissions in those of the SCVT Trades (conducted by the State) will be awarded State Trade Certificates by the State Council for Vocational Training on their successful qualification of ensuring State Trade Test.
