Terms and conditions:-

11. The academic arrangement shall be for a period of one academic year only. The arrangement shall terminate automatically after completion of academic year 2013-14 or till posts are filled up on permanent basis whichever is earlier.
12. The candidates engaged as such shall be paid monthly remuneration of Rs 6000/-per month for Degree/Diploma holders and Rs. 5500/-per month for ITI holders.
13. The selection of the candidates shall be made by the Director Technical Education amongst the eligible candidates having applied for such arrangement after completion of the Trade wise merit list by the committee to be constituted by the department for the purposes.
14. Mere submission of application or eligibility shall not entitle any candidates for this engagement and the arrangement shall be made only as per the requirement/ number of posts available in the respective Institution/Trade.
15. Incomplete application not supported with documents shall be rejected without any notice to the candidates.
16. The application addressed to Director Technical Education shall be deposited with Principle, K.G. Polytechnic, Gogji Bagh Srinagar for Kashmir Division and Principal Government Boys Polytechnic, Bikram Chowk Jammu for Jammu Division Polytechnics.
