Applying Date:

Applications shall be invited from 1^{st} to 31^{st} of July of each year.

The application received after last date shall not be entertained.

Fee Structure.

The state Government shall charge processing fee amounting to Rupees, 10,000/- Non-refundable in shape of Demand Draft payable to Accounts Officer, Directorate of Technical Education, J&K from the newly proposed Private ITIs. Demand Draft shall be enclosed with the application.

procedural set up for conveying provisional permission.

- The State Director shall scrutinize the applications and judge their authenticity and financial position and feasibility in context to already available training facilities in the vicinity and employability potential in the proposed trades. He shall instruct Infrastructure Verification committee formed at Division level by the Government to inspect the campus and check the site plan and building drawings indicating various sections, Workshops as per the space norms earmarked for each trade. Such inspections shall be conducted from 1st August to 30th September each year.
- Deficiencies pinpointed by Verification Committees during 1st inspection in certain proposals shall be recorded in the committee report and shall be intimated to the concerned applicant immediately. 2nd inspection/verification of these institutes shall be conducted by 15th of October each year and till deficiencies are not rectified, the cases shall not be recommended to the Director Technical Education.
 - Infrastructure Verification committee shall recommend deserving cases to State Directorate up to 30th November each year.
- Recommendations submitted to Directorate of Technical Education by the Divisional Infrastructure Verification Committees shall be reviewed/re-examined by a Technical Verification Committee constituted by the Government for the purpose.
- Based on the report submitted by the Technical Verification Committee, State Director shall convey provisional permission by the end of February to the deserving applicants only for creation of infrastructure in the first instance which shall be extendable for a further period of 02 years.
- Management of the institute shall make all necessary arrangements and infrastructural facilities available for the proposed trades and units as per the prescribed norms by end of May.



- On receipt of the communication and supporting documents from Management of Proposed ITI, State Director shall again direct the infrastructure verification committees to inspect the campus of the proposed Private ITI and submit the recommendation/verification report to the Directorate. Acceptance/rejection of proposals shall be recorded by the inspection team clearly mentioning reasons thereof, within the ambit of standing Guidelines/Norms prescribed by GOI/SCVT.
- Management of the proposed ITIs whose proposals get rejected shall be intimated about the shortfalls/deficiencies; which may approach the Directorate for re-inspection once the shortfalls/deficiencies are rectified.
- After verifying the available infrastructural facilities and the arrangements made for starting a training course, Technical verification committee shall recommend the names of Institutes alongwith Trades/Units for which permission needs to be accorded to the Director Technical Education, who shall forward the case of the deserving applicants only to the Government alongwith recommendations for approval.
- After receiving the approval from the Administrative Department,
 Director Technical Education, J&K shall formally convey the same to the management of the institutes by end of June along-with list of trades/units.
- Recommended Institutes will be enlisted in the admission notice which shall be published by Director Technical Education during the month of July for the ensuing academic session.
- Quantum of monthly tuition fee etc shall be worked out for the Private ITIs after placing it through the Administrative Department, before the Fee Structure Committee for approval.

The Institute granted permission to conduct training under SCVT norms shall have to give an undertaking regarding:

(a). Quantum of monthly tuition fee fixed by the Government shall be charged from the trainees enrolled.

(b). Staff engaged by the Institute shall be paid at par with the remuneration of the staff working in Government ITI's on academic arrangement basis.
