- i) The above appointee shall report to the concerned Government Polytechnic alongwith all original certificates.
- ii) The appointee, if already in service/otherwise, shall given undertaking in the shape of an affidavit to the effect that:
 - a. If on verification the qualification certificate/reserved category certificate/experience certificate (wherever applicable) is found forged, false or fake by the concerned issuing authorities, the appointee shall have no claim for appointment and his service shall be deemed to have been terminated ab-initio. Further his appointment shall be subject to the final verification of Character and Antecedents form the CID in terms of Government Order No. 528-JKGAD of 2021 as amended from time to time;
 - b. The salary of the appointee shall not be drawn and disbursed to him unless and until the satisfactory report/genuineness of the certificates in respect of (ii) (a) above is received.
 - c. The Cadre allocated by the appointing authority/SSB shall not be changed under any circumstances by any authority/department/HOD/Officer.
 - d. The appointment shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he shall also be liable for criminal prosecution.
- iii) The appointee shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O No. 192 of 2020 dated 17.06.2020.
