Background:

1. DGT has allotted a quota of 06 Government ITIs for receiving funds under STRIVE Project.
2. Accordingly, 08 shortlisted ITIs from J&K uploaded their Institute Strategic Plan (ISP) online on Collect App of Strive Project which were forwarded by DGT to UT-Project Implementation Unit (UT-PIU) for Evaluation as per Standard Evaluation Procedure.
3. ISPs of all the 08 ITIs were Evaluated by UT-PIU in its meeting held on 11-01-2021 and 07 ITIs namely ITI Anantnag, ITI Baramulla, ITI Ganderbal, ITI Sopore, ITI Kishtwar, ITI Udampur and ITI Mendhar were recommended by UT PIU members. Name of ITI Kulgam could not figure in list due to grading issue.
4. List of recommended ITIs is to be forwarded to National Steering Committee (NSC) for formal approval by or before 10-02-2021.


