NOTICE INVITING TENDERS

For and on behalf of the Governor of Jammu and Kashmir State, e-tenders are invited from the Registered Firms/ Authorized Dealers/ General order suppliers for the Supply of Raw Material Items for use in Industrial Training Institutes of Kashmir Division for the FY 2019-20-21. The Tender document can be downloaded from www.jktenders.gov.in. The bids shall be accompanied by Demand Draft amounting to **Rs. 200. 00 (Rs Two hundred only) per Group** as a cost of tender document and Earnest Money deposit in the shape of CDR/FDR amounting to **Rs 10'000.00 (Rs. Ten thousand only) each for groups A and C, Rs 5'000.00 (Rs Five Thousand only) each for groups B and D and Rs 8'000.00 (Rs Eight Thousand only) for group E**. The cost of tender document as well as the EMD shall be pledged in the name of Joint Director (Kashmir), Technical Education, Srinagar, J&K on the Terms and Conditions given below.

Covering:

The Bidder/Tenderer shall submit their bids online in two cover system. The Bidder shall also have to submit the hardcopies of Cover - I (containing original Affidavit, DD and EMD) as per the schedule mentioned in the abbreviated tender notice. Cover- II shall only be submitted online. **The Bidder submitting hardcopies of filled BoQs shall be out rightly rejected.**

1. Cover- I "Technical Cover" Will contain

- A. Earnest Money Deposit and cost of Tender (in original) as prescribed.
- B. Attested copies of the following documents.
 - i) PAN, GST Registration.
 - ii) Latest GST Returns.
- C. An affidavit duly attested by 1st Class Magistrate on Non-Judicial Paper to follow the decisions of DLPC as per the format enclosed.

2. Cover- II "Financial Cover" will contain

- A. Price bids (BoQs) in which Bidder/Tenderer shall quote their rates for items and shall be submitted online.

GENERAL CONDITIONS

1. Financial bid of only those Bidders/Tenderers shall be opened and considered for evaluation that would be declared successful in technical qualification, by technical Committee/DLPC.
2. The Bidder / Tenderer should attach a copy (self attested) of PAN, GST Registration and Latest GST Return with the bid.

3. The Bidder/Tenderer shall submit their bids online in two cover system. The Bidder shall also have to submit the hardcopies of Cover - I (containing original Affidavit, DD and EMD) as per the schedule mentioned in the abbreviated tender notice. Cover- II shall only be submitted online. The Bidder submitting hardcopies of filled BoQs shall be out rightly rejected. The bidding process shall be item wise. In case the bidder does not have to quote for any item, the bidder must leave the BoQ cell for that particular item Blank. **Bidders in no case shall quote Zero (0) in the BoQs.**
4. Samples will be sought where felt necessary, and the same should be kept in readiness, so that same can be provided to the Purchase Committee, as and when asked, within a period of 05 days failing which the offer will not be considered. The samples will remain in the custody of the Department at any place as per their convenience till the supplies are received in full and verified thereafter.
5. In case, of any shortfall in the ordered supply by the Bidder penalty @ 5% (Five percent) of the total cost of the order shall be recovered from him/ them.

7. **Rates quoted must be inclusive of all taxes applicable (GST etc) FOR destinations mentioned above (i.e. S.No. 06).**
8. The quantity mentioned in the tender document may increase or decrease as per the availability of funds and other related variations.
9. Each Bid/Offer shall be accompanied with a "Call Deposit Receipt/ Fixed Deposit Receipts" equivalent to amount mentioned in the abbreviated tender notice for each specific group from any scheduled bank pledged to the "Joint Director (Kashmir), Technical Education, J&K, Srinagar". The CDR/FDR should have the validity of one year. No Cheque or Bank Draft in lieu of Call Deposit Receipt/FDR shall be accepted in any case.
10. The successful Bidder / Tenderers shall have to execute an agreement with the Department within 07 days after acceptance of the Tender is communicated to him. Failure to execute such agreement, the terms and condition embodied herein shall be enforced against him and any loss sustained by the Department in re-tendering shall be recovered from him besides forfeiture of the CDR/FDR.
11. Rates shall remain valid for a period of One Year from the date of issuance of rate contract.
12. Any condition not laid down in NIT, decision of DLPC shall be final.
13. In case of any dispute arising between Tenderer and Department regarding incorporation of any of the terms and Conditions of the NIT or any matter








connected or incident, it shall be referred to the Director, Technical Education Department, J&K or any other person nominated by him in this behalf for arbitration, his decision in the matter shall be final, conclusive and binding upon the parties. All the disputes between the parties evolving legal intervention shall be subject to the jurisdiction of J&K High Court, Srinagar.

14. The hardcopies of Bids / Offers (**Cover I only, containing Mandatory Original Affidavit, DD and EMD**) should be submitted in the Office of the JOINT DIRECTOR (KASHMIR), TECHNICAL EDUCATION, BEMINA, BYE-PASS, SRINAGAR by or before **28.12.2019 up to 4:00 PM** on the working days only. In case the last day being a holiday the same shall be accepted on next working day.
